INTRODUCTION

The South Asia region was ranked the lowest in the world in terms of declared marine and coastal protected areas in the 2003 United Nations List of Protected Areas. In addition, the inclusion of essential coral reef habitat in MCPA provisions is minimal, making the Indian Ocean, with its wealth of coral reefs, seagrasses, and mangrove forests, perhaps the most poorly protected ocean. As a result, the degradation of coastal and marine resources continues at an unprecedented rate, and despite current protection measures, one third to half of the coral reefs of South Asia are now effectively dead, and a further 30% threatened.

The 2004 Status of Coral Reefs of the World report identified the major factors contributing to the continued resource degradation at MCPA sites encompassing coral reef habitats, prior to the Indian Ocean Tsunami event. This report specified limited interagency and governmental cooperation as an inhibitor to effective resource management across the South Asia region and recommended the introduction of overlapping and complementary mandates.

To improve marine and coastal resource management effectiveness in the South Asia region, stronger institutional links are needed across sectors, between policy developers and grassroots communities, for improved information exchanges, greater representation of stakeholders in management decision-making processes, and the effective implementation of identified national and regional priorities.

The establishment of the South Asia Coral Reef Task Force (SACRTF) to facilitate the implementation of regional and international initiatives in the management of coral reefs and associated ecosystems, and to promote collaborative action, and transboundary responses to shared environmental challenges, was by endorsed by the country governments of the 5 maritime nations of South Asia, at the SACEP Governing Council Meeting in Nepal, in January 2007.

Through extensive consultation with key regional stakeholders, the role, mandate and structure of the SACRTF was developed, and the resulting constitution document endorsed by the participants of the second regional resource coordination workshop held on the 25-27th July 2007, in Colombo, Sri Lanka. SACRTF representatives have been selected in accordance with the constitution document and regional nominations.

This working meeting is the first official meeting of the SACRTF representatives was held on 21st December 2007 in Colombo. The Chief Guest on this occasion was Hon. Mr. Ahmed Abdullah, Minister of Environment Minister of Environment, Energy and Water, Republic of Maldives and Hon. Mr. Patali Champika Ranawaka, Minister of Environment & Natural Resources, Government of Sri Lanka was the Guest of Honour. The meeting was attended by the national members of the South Asia Coral Reef Task Force from Bangladesh, India, Maldives, Pakistan and Sri Lanka. The International Community represented by IMM and IUCN.

The Meeting was held with the following objectives

1.1 Identify specific activities under each of the SACRTF priority implementation areas and develop a robust work plan, noting each activity lead, timeframe for implementation, and considering the following needs to:

1.1.1 Communication

 Identify a mechanism to advance and implement the SACRTF Exchange Programme in 2008.

1.1.2 Policy

- Identify an ICRI focal point to participate in ICRI General Meetings.
- Identify an agenda item and supporting materials for presentation at next SACEP GC.
- Develop a strategy for engagement with key coral reef entities: EACRTF, GCRMN, ICRMN, National Coral Reef Committee (India) & others.

1.1.3 Fundraising

- Identify an IYOR focal point for the SACRTF, and develop a roll out strategy for the effective coordination of a regional response to IYOR 2008.
- Identify a mechanism, and key actions to advance discussions with country governments on the sustainable financing and institutionalisation of the SACRTF.
- 1.2 Harmonise meetings/events calendar with the availability of members. Inform and update the SACRTF on the Sustainable Livelihoods Enhancement and Diversification (SLED) activities and outcomes in the South Asia MCPA Project, and consider how the SACRTF can help to advance the uptake of the SLED approach in the region.
- 1.3 Identify profile-raising materials required by the SACRTF and the process for their development.
 - A strategy for the assessment of 'Environmental Education Call to Action proposals', and a deadline and process for notifying successful candidates.

INAUGURATION CEREMONY

Inauguration with Lighting of Lamp by the Chief Guest Hon Mr. Ahmed Abdullah, Minister of Environment Energy & Water, Republic of Maldives and Guest of Honour Hon. Mr. Patali Champika Ranawaka, Minister of Environment Natural Resources, Government of Sri Lanka, and representative of Hon. Patron Judge C. G. Weeramantry, Former Vice President, International Court of Justice.

- Dr. Arvind Boaz, Director General of SACEP provided the welcome address to
 participants and invitees on behalf of the organising committee, who said that the
 significance of this initiative to SACEP is honoured to host this Task Force at the
 SACEP Secretariat and pledged its fullest support to ensure the meeting of the
 objectives of this Task Force.
- Speech of Hon. Patron-SACRTF, Judge C. G. Weeramantry, Former Vice President, International Court of Justice & Hon. Patron of SACRTF (Read by Mr. Neshan Gunasekera) and encouraged an inclusive, important meeting at which guidelines will be laid down for the future work of the SACRTF.
- Address by Guest of Honour Hon. Mr. Patali Champika Ranawaka, Minister of Environment and Natural Resources, Government of Sri Lanka highlighted the SACRTF would facilitate the implementation of regional and international initiatives in the management of coral reefs and associated ecosystems, and to promote collaborative action, and transboundary responses to shared environmental challenges, which was endorsed by the country governments.
- Address by Chief Guest Hon Mr. Ahmed Abdullah, Minister of Environment Energy & Water, Republic of Maldives delivering the keynote address briefed the meeting on the importance of preserving this fragile ecosystem and went on to speak at length on the outcome of the recently concluded Bali Meeting on Climate Change. He said that the outcome of this meeting was very encouraging and that the decisions taken saw new hope for the preservation of the climate for future generations.

SESSION 1

1.1 INTRODUCTORY SESSION led by Dr. Arvind Boaz, SACEP

The meeting adopted the agenda and after the introductory presentation of the SACRTF by Dr. A.A. Boaz, Dr. K. Venkataraman, was appointed as the official reporter of the meeting. Participants worked in 3 different groups to discuss the key challenges of facing marine and coastal stakeholders in the region under the 3 different topics Coordination, Communication, Research, Monitoring and Policy. Each Group were asked to reflect on the broader context of one or more of the 4 priority areas and the implications in the constitution to identify concrete actions that can be taken to advance each area. The groups were asked to provide guidance to the project in its development of tools and services to assist communication within the region. Presentation of group outcomes were discussed with all participants and adoption of activities, lead representative within the SACRTF, and timeframe for each suggested action.

Several key points emerged from this group discussion other than the distributed position paper. The recommendations of each group are given below.

Group-1: COMMUNICATION

Ms. Gayathri Sriskanthan, Programme Officer, IUCN presented the Group out come

- **1. Reporting mechanisms**-Need for a quarterly report mechanism, based on a standardized reporting format which will be submitted by the focal points at the national level to the SACRTF secretariat/regional focal point and shared via the MCPA website.
- **2. Capacity building activities-**SACRTF should support capacity building targeting 3 major areas (1) MCPA managers; (2) Schools and communities, and; (3) Research and monitoring.
- **3.** Identify Strategic partnerships and linkages to the regional and international level-SACRTF should try to institutionalize existing informal links with regional and international bodies; strategically present itself at key national, regional and international fora, and; formalize a SACRTF position statement.
- **4. Awareness of decision and policy makers-**SACRTF should improve the understanding of policy and decision makers through engaging with existing environmental fora at the policy/decision making level; publicize its position statement with civil society organizations instrumental in lobbying activities in the region.

Group-2: COORDINATION

- **Dr. B.P. Nilaratna,** Joint Secretary, Ministry of Environment and Forest, India, presented the Group out come and participants further emphasised several key issues that are relevant to the development of an appropriate coordination strategy for the project:
 - Multilateral Linkages-Lead and facilitate the development of strong multilateral linkages for all aspects of coral reef management within and between countries by engaging strategic stakeholders in SACRTF activities, and providing a focal representation Ministry Central or Federal Government Departments for coral reef management.
 - Focal Point
 - Ascertaining Stakeholder Concerned
 - National and Provincial, District, Local levels
 - Stakeholders Local Community, NGO's, Local Governments, Law Enforcing Authorities, Research Groups
 - 2. Capacity Building Local, National, Provincial, District and Local
 - **3. Regional Initiatives** Work alongside key national stakeholders to establish national Coral Reef Task Forces (CRTF), with multi-sector representation, to support the development of National, Provincial, District and Local capacity in research, management and government, coordinate communication at the national level, and serve as a platform to share information with regional initiatives and exchange of information at regional level for actions and remedies.

4. National Action Plan

- A) Examine capacity needs National, Provincial, District, Local Levels.
- B) Review of Existing Mechanisms Lacking and Improvements
- C) Methodology of capacity building Electronic, Print Media, Public meetings, Field visits, Seminars, School curricula, Hoardings etc
- 5. Regional Actions Strategy- Prepare a regional coral reef action strategy, and Legal Framework incorporating the key findings on the development and implementation of a networked system of MCPAs across the South Asia region, and identify supporting frameworks for effective implementation.
- **6.** Regional Mandate Coordination Examine capacity needs, evaluate and review existing mechanisms for coral reef conservation and management, and where

appropriate encourage each country to design national action plans or equivalent strategies, under the umbrella of the regional action strategy.

- Focal Point Institutions Initiate discussions regarding the development of a coordinated regional mandate or mechanism to more effectively respond to natural and man made disasters.

 - Increase co ordination potentials at Different Levels

Group 3- RESEARCH, MONITORING, POLICY, AND FUNDRAISING

Mr. Ben Cattermoul, Livelihoods, Planning & Economics Specialist of Integrated Marine Management Ltd presented the Group outcome.

POLICY

- Policy Review- Undertake a review of existing policies related to coral reef management and conservation in the region, in collaboration with the SACRTF Patron, and present the findings to authorities to influence the review of existing legislation and policy change at the national level as appropriate.
 - · Policies that directly relate to reefs
 - Develop Structure
- Elevate the South Asia experience to the international level by engagement in ICRI. 2 member representative of the SACRTF to will participate in ICRI General Meetings.
- 3. **SACEP GC**-Raise awareness of the need for political engagement in coral reef management through high-level political segment meetings. The SACRTF will present specific agenda items at each SACEP Governing Council meeting to raise awareness of needs, and develop political will in support the SACRTF.

RESEARCH AND MONITORING

- **1. Activity**-Identify the strengths in each country in all aspects of research and monitoring related to coral reefs. Develop a mechanism to ensure knowledge and training is shared and exchanged among the participating countries in accordance with needs.
 - Action Plan for Biophysical, Social aspects should be prepared.
 - Training for monitoring
 - Review International Best Practice.
- **2.** Review of Research and Monitor- Encourage each country to effectively establish national monitoring programmes for coral reefs and associated ecosystems and recommend better coordination within and between countries in the region in the design and implementation of monitoring programmes.
 - Who, What, What for, How to get, How used and identify existing research strategies.
- **3.** Research Production-Promote both biophysical and socio economic assessment/monitoring action Plan and more effective coordination with regional and international monitoring programmes.
 - Recommendation from Ministers on importance of coral reefs conservation and statement on livelihoods and reefs.
 - Review existing information and new institutes, Prepare structure for survey and Distribute survey and request reports, Review International Best Practice.

FUNDRAISING

- **1.** Raise the profile of coral reefs issues and successful initiatives in the region in order to garner support from donor community and attract funds.
- **2. Package existing or new activities** to create a regional effort in support of the International Year of the Reef 2008, and other mass awareness raising campaigns.
- **3. Meeting calendar** of coral reef forums, venues and meetings, against the movements of SACRTF representatives to maximise representation of the SACRTF regionally and internationally.
- **4. Budget projection** for the annual maintenance of the SACRTF to present to country governments, to advance the identification of a sustainable structure and funding mechanism to ensure the continuation of the SACRTF.
- **5. Existing national budget allocations** for coral reef conservation and management to identify potential financial support for the SACRTF.

RECOMMENDATIONS

Outputs of the discussion of all the 3 groups will be developed through future activities in close collaboration with participating institutions and following recommendations were emerged from the discussion:

- Participants highlighted the importance of appoint Focal Point National Coordinator to link the National and Regional activities of the Task Force.
- Concerns were raised in the development of education curricular including coral reef information discussed as possible ways to include in all 5 maritime nations.
- Develop standardized reporting format by the end Jan 08 and 1st quarterly report shall be submitted by end March 08.
- Select MCPA manager level participants for (a) MCPA Managers toolkit, (b) site level exchange activities by end Jan 08. Identify national/ regional experts on MCPA issues and management for the development of training activities by end Jan 08.
- Develop a short list of regional and international bodies of relevance with focal point contact details— to be made available on MCPA website and formally introduce SACRTF to the identified regional and international focal points by end March 08
- Create plan of action for engaging with education/community outreach initiatives by end August 08 by the Regional focal point in collaboration with national focal points.
- Review of information on Research and Policy within the region and prepare a
 central data base/ information center at SACEP. Establish mechanisms to ensure
 that the work both builds on past experiences in the region and that it effectively
 informs future plans and interventions.
- Prepare structure for survey for the review of existing information on research and new institutes and distribute survey and request reports, website etc.
- Within next 6 months, policy review, identify lacking and general statement and enforcement mechanism on conservation of Coral Reef by the country governments. SACEP GC Recommendation from Ministers on importance of coral reefs conservation and statement on livelihoods and reefs.
- Ensure that this component of the project is clearly and effectively linked into other programme activities.

SESSION 2

Activities of SACRTF led by Dr. Arvind Boaz, SACEP.

Dr. Boaz made following presentations to brief the members about the various issues to be discussed as per the agenda.

2.1 Identification of an International Year of the Reef 2008 (IYOR) focal point and key messages and activities for inclusion on the SACRTF profile.

The International Coral Reef Initiative designated 2008 as the International Year of the Reef (IYOR 2008). IYOR 2008 will be a year long global campaign to raise mass awareness on the importance of coral reefs and the need for their sustainable management. Only one other region is currently presenting a coordinated regional response to the IYOR 2008 challenge.

Potential role of the SACRTF in leading a regional level response to IYOR were agreed by participants as an excellent mechanism to not only generate political will for coral reef conservation and management, but also to raise the profile and visibility of the SACRTF within the region.

IYOR 2008 focal point to coordinate the effort, and generate an organisational profile for the SACRTF on the IYOR website (www.iyor.org). In developing this profile representatives will need to supply contact information, and details of specific activities that will be undertaken, or showcased by the SACRTF in support of IYOR in 2008. (Further information is included in Annex 5.) It is noted that the East African Coral Reef Task Force also has an IYOR 2008 organisational profile page.

2.2 Environmental Education Call for Action and defining the process for Proposal Review.

A Call for Action was released in September 2007, through the South Asia MCPA Project, to request short proposals from each of the 5 participating MCPA sites for activities that raise awareness among coastal communities of the importance and value of coral reefs, and which help to demonstrate the role of MCPAs in their sustainable management. The deadline for proposal submissions is 31 December 2007. (Further information on the Call to Action is included in Annex 6.)

2.3 Sustainable Financing and Institutionalisation of SACRTF by Dr. Arvind Boaz

Projected annual budget of the SACRTF was presented and asked to identify key actions/ materials to advance institutionalisation of the SACRTF with country governments. Members were adopted the annual budget and possibilities for match funding from country governments was highlighted to this targeted initiative.

2.4 Coral Reef Livelihoods Initiative (CORALI): The role of the SACRTF in advancing the SLED approach.

Under the South Asia MCPA project, activities are underway with field teams and coastal communities in the 5 participating countries to develop and test a globally appropriate approach to sustainable livelihood enhancement, diversification and change in the context of coral reef management. Detailed information on the approach, and case studies to demonstrate the impact and success of the approach with communities from sites across the region, presented by **Mr. Ben Cattermoul,** Livelihoods, Planning & Economics Specialist of Integrated Marine Management Ltd at the meeting.

CORALI partners will coordinate a policy forum in the first quarter of 2008 to raise the profile of the SLED approach and to promote the uptake of new and effective livelihood approaches regionally. Further information on CORALI is (*included in Annex 8*), or can be viewed at www.coraliweb.org

Following the presentation by Mr. Ben Cattermoul, the issues of monitoring and evaluation criteria of SLED approach was discussed. It was felt that an independent review of this approach should be undertaken in order to identify how effective this approach has been raise the livelihoods of the dependent population. This is necessary before this approach can be proposed to be adopted in the region.

2.5 SACRTF Work Plan / Event Calendar mapping and allocation of SACRTF budget.

A suite of management plans, policies, and national and international strategies exist to support the management of marine and coastal resources in the South Asia region. However, the realisation of policy and strategies at the ground level is often poor. As such, the SACRTF has been established with the following mission statement:

'To actively participate in, and support, the effective implementation of existing national regulations, action plans and strategies for the management of coral reefs and associated ecosystems, and to promote the development of strategic linkages for enhanced regional cooperation, and the establishment of an effective, networked system of marine and coastal protected areas in the South Asia region.'

A list of broad priority actions was endorsed at the second regional workshop to form the basis for the annual SACRTF work plan. The meeting representatives were requested to identify specific activities that can be undertaken in support of each action, a lead party, and a timeframe for implementation. The SACRTF were also requested to consider the following opportunities in the elaboration of the work plan:

• Capacity Development Training for MCPA Managers

IUCN Asia and ICRAN are leading the adaptation of the highly successful 'Western Indian Ocean toolkit for managing MPAs' for the South Asia context. The modular toolkit will provide simple reference materials on a wide range of subjects relevant to effective management. Case studies are currently being collated from across the region to showcase the successful activities already underway, and regional training for MCPA managers will be conducted in May 2008 on the use and application of the toolkit in MCPA management.

• SACRTF Managers Exchange Programme

The SACRTF was established with a key strategic objective to promote the effective implementation of Marine and Coastal Protected Areas (MCPAs) and to advance the concept and discussions of a network of MCPAs in the South Asia region.

To develop the capacity of resource managers at existing MCPAs in preparation for network development, and in order to meet the objectives of the South Asia MCPA Project under which the SACRTF is established, the SACRTF will establish and coordinate a programme of exchange or exposure visits for MCPA managers and policy makers from across the region, allowing countries and sites to benefit from each others experiences and management efforts, and demonstrating management challenges and successes at MCPA sites. Based on the extent and well manage sites among the 5 maritime nations, Mahatma Gandhi National Park and Andaman Islands, India was selected as the first site.

ICRI

The development of linkages to the International Coral Reef Initiative (ICRI), and the attendance of a SACRTF representative (in addition to the Member Secretary) at each ICRI General Meeting were identified as key opportunities to feed regional information into government and policy processes, alongside raising the profile of the SACRTF among the international donor community. The next ICRI General Meeting will take place in Washington from 22-25th January 2008. SACRTF representatives were requested to identify a participant and feedback to the ICRI Secretariat on the nomination. Representatives were requested to consider key profile-raising materials required for this purpose and the process for their development. (*Further info on ICRI is provided in Annex 4.*)

SACEP Governing Council

The SACEP governing council (GC) is the principal deliberative and review body responsible for determining policies, strategies and programmes of SACEP. It is represented at the ministerial level and periodically meets to take decisions of strategic significance. Since becoming a legal entity in 1982, SACEP has held eight regular GC meetings and three special sessions. The establishment of the SACRTF was officially endorsed at the SACEP GC meeting held in Nepal in January 2007 by all participating country governments. The next SACEP GC meeting will be conducted in early 2008 and representatives were asked to consider developing an agenda item for the GC which will help to advance the SACRTF work plan.

Meeting Harmonisation

Provision has been made in the SACRTF budget to facilitate the attendance of SACRTF representatives at meetings of strategic importance for regional/local priorities, and the work plan priorities of the SACRTF. In order to ensure good representation at international meetings, raise the profile of SACRTF activities, and effectively administer the limited funds available, representatives were requested to review the calendar of events and meetings presented and inform the Member Secretary of any events to which their attendance is already planned. (Calendar of events is detailed in Annex 1)

Key points emerged from this discussion:

- Dr. Boaz highlighted the role of the project in supporting the development of human and technical capacity at existing MCPAs across the region. For the IYOR 2008, Brand Ambassador could be selected from famous singers, sports persons etc for raising profile of the Coral Reef Task Force and the activities planned for implementation at 5 sites across the region of ideal characteristics to be demonstrated by potential sites, to support the implementation of these activities.
- The importance of understanding current livelihood strategies and as a starting point for working towards livelihood development and change.
- It was requested that MCPA sites with common resource properties, such as
 encompassing coral reef and associated habitats in their boundaries, be the focal areas
 for this initiative to facilitate the replication of effective actions between sites, and focus
 efforts for a greater deliverable impact through the project.
- Identify regional/international fora that SACRTF should be engaging with (e.g. ICRS, ITMEMS and draft time table of key regional/international fora that SACRTF will be engaging with over 2008 and develop a strategy of engagement with these fora that support SACRTF's core aims, climate change fora, UN processes) by the end of Feb 08.
- Present SACRTF position statement to the SACEP governing council meeting and develop SACRTF position statement and communicate this at ministerial level by the end June 08.
- Identify civil society organizations that lobby policy/decision makers; communicate the priorities identified by SACRTF to these organizations by the end June 08.

RECOMMENDATIONS

Based on the presentations and the subsequent discussion, the following recommendations for the implementation by the Task Force were agreed upon:

- The possibilities for match funding from country governments and other international funding agencies were highlighted to this targeted initiative.
- Identification of 5 proposals for the implementation of project activities under the Environmental Education Call for Action representatives from all 5 countries, appropriateness of extension of the Proposal date till 31st January, 2008 for the

nominated sites in accordance with the suggested criteria. It was clarified that it is obligatory in the "call for Action" that the proposal should be submitted by the MCPA management staff in collaboration with others. Short listed proposals will be then reviewed according to the potential for demonstrable impact that might be realised through the project at each site. SACRTF representatives were requested to identify a strategy for the assessment of proposals and set a deadline for announcing the successful candidates.

- It was resolved that the funds for this activity will be administrated by the member secretary of SACRTF who will act as a focal point for this exercise and develop the contracts based on the successful proposal. The member secretary is authorised to get necessary funds to be allocated to the MCPA Mangers.
- It was noted that each site will be allocated adequate resources from the project for the
 implementation of training, enforcement and education programmes. These
 programmes will be developed in collaboration with local partners and management
 agencies to ensure a complementary and appropriate local focus and to add value to
 the existing efforts. Where appropriate, lessons learned will be transferred between
 sites related to the development and implementation of training.
- The Government of India will select one of the major coral reefs sites for the managers exchange programme and India agreed to facilitate the programme. It was noted that all training and capacity building activities would be implemented in conjunction with the selected sites, to address multiple elements of management, enforcement and education, and to encourage the improved operation and outputs at these sites and their use as better management practice examples within countries and across the region.
- The exchange/exposure visit programme should focus initially on the 5 MCPA sites selected for inclusion in project activities. SACRTF representatives are requested to identify a suitable mechanism for participant selection, and a supportive administration structure.
- It was decided to review the benefits of the SLED approach to the local population in order to identify, in real terms the effectiveness of the approach and then subsequently to think about proposing the adoption of the approach for the region.
- Along with the member secretary, chairperson of the SACRTF will participate in the next ICRI General Meeting which will take place in Washington from 22-25th January 2008, and the nomination will be sent to the ICRI Secretariat.
- Discussions and facilitation of communication between marine and coastal stakeholders within the region will be developed and identification of options and priorities for a unifying communication strategy will be done.
- June 2nd 2008, as appropriate date for a second regional meeting to finalise draft outputs resulting from this meeting. Country Governments are asked to nominate their representatives to ensure effective allocation of the SACRTF budget, and can facilitate the identification of a suitable location for the next SACRTF meeting.

SESSION 3

SACRTF ADMINISTRATION led by Dr. Arvind Boaz, SACEP

3.1 Adoption of TOR for Chair and Member Secretary

Selection of SACRTF Chairperson

The agreed SACRTF constitution states that selection will be by consensus of the SACRTF, from a nominee among the country government representatives, and that the Chairperson must serve for a period of one year. A TOR was approved (included in *Annex 10*) by the SACRTF representatives at this meeting.

Member Secretary

The Director General of SACEP will serve as the Member Secretary of the SACRTF to provide continuity and administration support to the SACRTF. A TOR is included in Annex 6 and SACRTF representatives were reviewed and adopted the TOR at the meeting.

3.2 Sustainable Financing of the SACRTF

Funds to support the initial establishment of the SACRTF have been generously provided by the European Union, through the South Asia MCPA project. After the project close on 31 December 2008, no further funds will be provided to the SACRTF. Participants at the second regional workshop recognised the need to develop a sustainable financing strategy as critical to ensuring the continuation of the SACRTF and the expansion of the network to incorporate national level coral reef task forces in each participating country. Projected budget for the annual operating costs of the SACRTF was presented and adopted at the meeting. (*Annex 7*)

3.3 Outreach Materials

First SACRTF introductory brochure was launched at the meeting and further proposed development of outreach materials such as Leaflets, Brochures, Posters, Video Clips, Newsletters etc. Young Asia TV will be contacted for a free video programme on regional sites.

3.5 MCPA Site Representatives

According to the constitution based on country nominations and decision of the 2nd Regional Workshop, temporary Members of the Selected MCPA Project sites to be nominated by the governments who will work on the Task Force till the National Task Force are formed.

3.6 SACRTF Logo

A Logo competition was launched across the region to develop a unique and exciting logo for the SACRTF. Submissions were presented to the participants of the second regional workshop for consideration. Some excellent entries were received; however participants felt that further design options were needed. Thus the SACRTF was requested to finalise criterias for logo development. Dr. Boaz presented following key attributes of the logo.

- The logo must be clear even when reduced to a size of less than 1 sq cm.
- The logo must give equal recognition to the five participating maritime countries.
- The logo must focus on the conservation and development of the coral reef and associated ecosystems.
- The logo must find some place for the abbreviations SACRTF.

Several key points emerged from this session discussion:

- The importance of linking work on livelihoods with effective environmental management measures, including enforcement.
- The importance of linkages and partnerships with institutions and initiatives that have long-term commitments to working with stakeholder communities - given the complexities involved in working on livelihoods, and the long timeframes often required in order to achieve sustainable results.
- The importance of feeding developed approaches and methodologies for working on livelihood enhancement and diversification into longer-term, on-going initiatives to enhance impacts.

RECOMMENDATIONS

The following recommendations were agreed upon during the course of discussions:

- The house unanimously decided India as the Chairperson for the SACRTF.
- Representatives suggested the most suitable way to remain in communication and coordination in between SACRTF meetings is through the member secretary of SACRTF who should set a regular communication to promote coordination.
- SACRTF representatives agreed on a representative from each MCPA site, if not already done so and ensure that they are included in all future SACRTF correspondence and meetings. Till such time that the country task forces are established and one member nominated them on the regional task force.
- Incorporate the effective application of information for coral reef management into capacity building training under the project.
- Pakistan has already nominated the Country Task Force and the secretariat requested the other country governments to form the National Task Force nominations.
- India has already National Committee on Coral reef and Mangrove which will function as National Coral Reef Task force and country Working Group including more members.
- The members of the task force thanked the EU for providing the generous finance for the project and establishment of the SACRTF. The members expressed their concern over the delay in the launching of the project and only about one year left for all activities to be completed in the project.
- It was decided that in order to ensure the smooth running of the project and ownership of the maritime countries, of the SA region, the project activities should be implemented by SACEP, which is the implementing agency of the project. It should therefore be ensured that all funds for activities under the project should be put at the disposal of SACEP to ensure the timely completion of the project. This is important as the member countries of SACEP have consented to this project as a project being implemented by SACEP.
- It was agreed to identify a strategy to advance discussions on the sustainable financing and institutionalisation of the SACRTF in the region at the SACEP GC.
- SACRTF representatives were agreed upon the listed detailed criteria of logo attributes, and re-advertise the regional logo competition. (see Annex 11)
- The criterias for the SACRTF logo were approved. The best date for entries of the logo competition should be kept 15th February after which the logo will be finalised by a three member sub-committee of the SACRTF consisting of the Patron, Chairman and the Member Secretary.

MESSAGE BY JUDGE C.G. WEERAMANTRY, FORMER VICE-PRESIDENT OF THE INTERNATIONAL COURT OF JUSTICE AND PATRON OF THE SOUTH ASIA CORAL REEF TASK FORCE (SACRTF)

KEYNOTE ADDRESS BY CHIEF GUEST HON MR. AHMED ABDULLAH, MINISTER OF ENVIRONMENT ENERGY & WATER, REPUBLIC OF MALDIVES

It is indeed a great honour for me to be present as Chief Guest at the First Meeting of the South Asia Coral Reef Task Force, under the European Union Funded Project titled Long Term Management and Conservation of Marine and Coastal Resources in South Asia.

ANNEX 4 – Background Information on ICRI

The International Coral Reef Initiative (ICRI) is a partnership among governments, international organizations, and non-government organizations. It strives to preserve coral reefs and related ecosystems by implementing Chapter 17 of Agenda 21, and other relevant international conventions and agreements. The ICRI was announced at the First Conference of the Parties of the Convention on Biological Diversity in December 1994, and at the high level segment of the Intersessional Meeting of the U.N. Commission on Sustainable Development in April 1995. ICRI was originally initiated by the governments of Australia, France, Japan, Jamaica, the Philippines, Sweden, the United Kingdom and the United States of America. Additional partners from governments, United Nations organizations, multilateral development banks, environmental and developmental NGOs, and the private sector have subsequently joined the original founders and are currently collaborating in the International Coral Reef Initiative. ICRI directly addresses one of the important issues identified in Chapter 17, Section 17. 86 that calls on states to:

"identify marine ecosystems exhibiting high levels of biodiversity and productivity and other critical habitat areas and should provide necessary limitations on use of these areas, through, inter alia, designation of protected areas. Priority should be accorded, as appropriate, to:

- Coral reef ecosystems;
- Estuaries:
- Temperate and tropical wetlands, including mangroves;
- Seagrass beds;
- Other spawning and nursery areas."

The International Coral Reef Initiative emerged out of the recognition that the coral reefs and related ecosystems found in tropical and sub-tropical regions are facing serious degradation, primarily due to anthropogenic stresses. Global estimations point that 10 percent of the Earth's coral reefs have already been seriously degraded and a that much greater percentage of coral reefs is under serious threat. Damaged or destroyed reefs can be found in more than 93 countries, with the coral reefs in South and Southeast Asia, East Africa and the Caribbean facing the greatest risk. It has been recognized that, if allowed to continue, this decline is likely to lead to the loss of most of the world's reef resources during the next century.

The international scientific community has been focusing the public attention on the serious decline of reefs for some years. Eventually, the concept of a Coral Reef Initiative to provide a focus on the plight of reefs and on the actions necessary to reverse the trend of degradation emerged at various international fora in 1994. It was founded on the clear recognition that many nations face similar threats to coral reefs and related ecosystems as well as similar management problems.

ICRI objectives call for:

- governments and international organizations strengthening commitment to and implementation of programs at the local, national, regional, and international levels to conserve, restore and promote sustainable use of coral reefs and associated environments:
- each country and region incorporating into existing local, regional, and national development plans, management provisions for protection, restoration, and sustainable use of the structure, processes and biodiversity of coral reefs and associated environments;
- strengthening capacity for development and implementation of policies, management, research, and monitoring of coral reefs and associated environments;
- establishing and maintaining coordination of international, regional and national research and monitoring programs, including the Global Coral Reef Monitoring Network, in association with the Global Ocean Observing System, to ensure efficient use of scarce resources and a flow of information relevant to management of coral reefs and associated environments.

The ICRI founding partners have formed an ICRI Executive Planning Committee (EPC) to oversee the development and review of workshop agendas and ICRI products and to provide overall guidance for the conduct of the Initiative.

In the Summer of 1995, an international ICRI workshop was held at Dumaguete City, the Philippines. The workshop provided a forum for governments, donors and funding agencies, development organizations, NGOs, the research community and the private sector to work together in order to develop a consensus framework for achieving sustainable management of coral reef ecosystems. Workshop participants endorsed a "Call to Action", which advocates international recognition that coral reefs are in serious decline globally due primarily to human activities, and a "Framework for Action".

The Call to Action and the Framework for Action have multiple applications. They provided the basis for the conduct of regional workshops to define regional needs and priorities and to catalyze the development of national coral reef initiatives. They promote the ICRI's goal of ecosystem and community-based management and encourage U.N. agencies and convention bodies, as well as multilateral and bilateral donors, to incorporate ICRI into their programs in order to better focus and leverage existing resources. They also identify important roles for the United Nations Environment Programme, the Intergovernmental Oceanographic Commission and the scientific community in monitoring and addressing the serious global decline of coral reefs.

ICRI is a unique environmental partnership that brings all the stakeholders together with the objective of sustainable use and conservation of coral reefs for future generations. ICRI is an informal mechanism that allows representatives of over 80 developing countries with coral reefs to sit in equal partnership with major donor countries and development banks, international environmental and development agencies, scientific associations, the private sector and NGOs to decide on the best strategies to conserve the world's coral reef resources.

Thus, ICRI is unique and its strength lies in the fact that it is a voluntary body with basic operational objectives. There are no plans to form a permanent structure with permanent staff, and funds spent on meetings are kept to a minimum. The agenda for ICRI has been set by over 80 countries and states with coral reefs expressed at 2 ICRI International Workshops (1995 and 1998) and 7 ICRI Regional Workshops between 1995 and 1997.

The ICRI Secretariat is deliberately kept small and temporary, with no permanent staff. To date, coordination staff have performed the ICRI tasks in addition to their other responsibilities in government. The ICRI Secretariat is advised by the Coordination and Planning Committee (ICRI-CPC), which meets once or twice per year, often opportunistically to coincide with other international meetings. In turn, CPC members are requested to facilitate the objectives and projects of ICRI.







ANNEX 8 – CORAL REEF AND LIVELIHOODS INITIATIVE (CORALI)

CORALI¹ has been designed to address the challenge of "how to better support livelihood development as key part of a more holistic approach to coral reef conservation". CORALI is funded to operate between 2006 and 2008. It incorporates three elements:

1 Skills and Knowledge Network

CORALI has begun the process of building a network of governmental and non-governmental organisations, working with coral reef dependent communities, within South Asia and Indonesia. At this early stage the core network teams have been supported through a process of workshops, which have enabled skills and knowledge exchange. A wider network is growing around the CORALI website, where the skills and experiences of the core teams are being used to promote a more people-centred approach to coral reef research and management.



2 Developing an Improved Approach to Socio Economic Monitoring

CORALI has been facilitating attempts to develop an approach to socio-economic monitoring that better serves the local context in coral reef dependent communities in South Asia. They have worked on building an approach that is accessible to the community as well as outsiders; low on development resources; provides updated reliable and relevant information; simplified / easy to understand; and transparent. In response to this challenge the CORALI partners have developed a tool (Reef Conservation and Action from the Peoples Perspective - RECAPP) that is designed to capture people's perceptions about changes in coral reefs and utilize local knowledge as a cost-effective way of identifying issues that may require more extensive biophysical or socio-economic monitoring.

3 Developing a Participatory Approach to Sustainable Livelihood Enhancement and Diversification (SLED) in coral reef dependent communities

The SLED approach was built to provide guidance for development practitioners whose task it is to assist people, from coral reef dependent communities, to enhance and diversify their livelihoods. The approach is designed to identify the key elements of best practice that should be addressed in the process of assisting livelihood change. Over the past 12 months 6 teams from across the region have worked to pilot test the approach in a range of communities.

The approach will be presented at a management and policy forum, which is scheduled to be held in February 2007.







- Participants at the second regional workshop recognised the need to develop a sustainable financing strategy as critical to ensuring the continuation of the SACRTF and the expansion of the network to incorporate national level coral reef task forces in each participating country.
- Representatives are requested to identify a strategy to advance discussions on the sustainable financing and instrutionalisation of the SACRTF in the region. To facilitate discussions and consultation with pouncy governments a projected budget for the annual operating costs of the SACRTF.

Helps people to take advantage of opportunities to Change the nature of their dependency on natural resources and support the concervation measures that have been put in place.



Task Force Discussion

SACTF administration issues



Selection of SACRTF Chair

A Chairperson must be selected to lead the SACRTF. The agreed SACRTF constitution states that selection will be by consensus of the SACRTF, from a nominee among the country government representatives, and that the Chairperson must serve for a period of one year. A TOR is included in Annex 10 for consideration. and SACRTF representatives are asked to review and adopt the TOR at this meeting.



SACRTF ADMINISTRATION: Terms of Reference

The Chairperson will perform the following supporting roles:

- Foster relationships and strategic partnerships to advance the work programme and financial sustainability of the SACRTF.
- Provide leadership to the SACRTF representatives, and assist in-providing appropriate input into the formulation of frameworks. strategies and work plans:
- Assist in the identification of focal areas of strategic importance for the SACRTF. In collaboration with CRTFs, and in line with regional and international agreements and strategies;
- Monitor the implementation and impact of the SACRTF and CRTF work plans, and communicate with representatives to ensure the timely delivery of planned actions:
- Represent the SACRTF at appropriate functions and meetings, and work alongside representatives and the Member Secretary to promote the SACRTF at the regional and international level; and
- Attend and chair SACRTF meetings.

The Meniber Secretary will perform the following supporting roles:

- Convene and coordinate each regional meeting of the SACRTF, in bonsultation with SACRTF representatives and host country. Act as a focal point for SACRTF representatives and administer the
- budget, facilitating travel arrangements, and regional/international meeting participation;
- Administer and coordinate the SACRTF MCPA Manager Exchange Programme in collaboration with key SACRTF representatives:
- Assist in the collation of minutes, and the dissemination and
- coordination of the outcomes of the SACTRF meetings, and activities: Work alongside regional governments and SACRTF representatives to promote the SACRTF at the regional and international level, and to fundraise for the sustainable politinuation of the SACRTF;
- Feed progress reports to partners and donors as appropriate, and
- Report to the SACRTF on a quartery basis (before 15th annuary, 15th April, 15th July, 15th October), to provide programmatic and financial updates to representatives. The first report will be due on 15th January 2008.

Adoption of TOR for Chair and Member Secretary

· The Director General of SACEP will serve as the Member Secretary of the SACRTF to provide continuity and administration support to the SACRTF. A TOR is included in Annex 6 for consideration, and SACRTF representatives are asked to review and adopt the TOR at this meeting.



Communications and Coordination


· Representatives will need to identify the most suitable way to remain in communication in between SACRTF meetings, and should set a regular contact schedule to promote coordination.



MCPA Site Representative

 In the agreed organisational structure of the SACRTF it was noted that a temporary representative from each selected MCPA site may participate in the SACRTF while national level iterations of the task force are established. SACRTF representatives will need to agree on a representative from each MCPA site, if not already done so and ensure that they are included in all future SACRTF correspondence and meetings.











SACRTF Logo
